By signing below, you agree to the following Dance Barre CREW commitments:

- Dancers agree to attend CREW classes on Saturdays from September 2019 – May 2020.
- Dancers agree to be punctual and ready to dance when class starts.
- Dancers are allowed four (4) absences from scheduled CREW classes throughout the year. Missing classes affects the CREW team and additional absences could result in consequences as deemed necessary by the Artistic Directors. We understand that this commitment must be kept for the entire 2019-2020 dance season.
- Although no allotments are made for absences to my Recreational classes, we understand the importance of good regular attendance as these classes help to improve technique, coordination, and skills.
- Attendance at competitions is mandatory. Dates for competitions will be provided in September.
- Attendance at the choreography session is mandatory. Dates and Specific times will be provided in June.
- Attendance at our Dance Innovation Show is mandatory. Dates will be provided by the end of September.
- We acknowledge that the price of CREW includes the choreography, one CREW intensive class per registered CREW, weekly CREW class, and CREW costume.
- We acknowledge that dance shoes, tights, make-up, accessories, competition fees and travel costs are additional costs not covered by the CREW tuition fee.
- **At the time of registration a \$100 down-payment charge per CREW will be processed by the method you have chosen in your Parent Portal Account once your registration has been reviewed.** The remaining balance of \$576 per CREW will be paid along with your class tuition either in full or throughout the year as you have chosen in your Parent Portal Account. The \$100 charge is non-refundable and once processed, no refunds will be given even if dropped before the start of the dance season. These prices include HST.
- We acknowledge that in order to participate in the CREW Team, I must remain enrolled in any pre-requisites recreational classes that apply throughout the entire dance season.
- **We acknowledge that each CREW dancer is required to take 5 hours of dance class during the Summer of 2019. This can be done through Private lessons, Drop-In classes, Intensive classes, or Dance Camp. CREW dancers will be asked to provide documentation supporting their participation by August 25th, 2019.**
- ****NEW THIS YEAR** CREW will be attending TWO competitions! Competition will be charged in addition to tuition. They will no longer be included in your monthly tuition. Competition fees range from \$55-\$75/each. The first competition fees will be charged to your Parent Portal account on October 1st, 2019 and the second competition fee will be charged to your Parent Portal account on December 1st, 2019. Competition dates TBD. I acknowledge that my competition fees must be paid in full in order to participate in the competitions.**
